If you pay Income or Capital Gains tax in the UK, Gift Aid is a great way to boost the value of your donations at no extra cost or trouble for you. Gift Aid is reclaimed by the charity from the tax you pay for the current tax year. We can reclaim the tax on all donations we receive that are gift aided either by a one-off donation or by regular standing order. Your address is needed to identify you as a current UK taxpayer.
